## JOINT LEGISLATIVE RESOLUTION

- **WHEREAS**, The strength and success of the State of New Jersey, the vitality of our communities, and the effectiveness of our American society depend, in great measure, upon concerned individuals such as Marc and Susan Goldstein, who use their considerable resources for the common good; and,
